Survey Information

[Indicator 14](#) is required to fulfill the district’s Indicator 14 data collection and reporting responsibilities as part of DPI’s [Collection of Cyclical Indicators](#).

- **Required Year:** LEAs (Public school districts and 2r Charters) are required to participate in data collection and reporting of Indicator 14 Survey data once within a five-year cycle.
- **Elective Year:** The remaining LEAs are invited to participate in the 2025 Wisconsin Indicator 14 survey.

[Special Education Transition Incentive Grant](#). Participation in the 2025 Indicator 14 Survey entitles the district to apply for and receive **up to \$1,000** for each district exiter meeting the criteria of participation in higher education, other postsecondary education or training, or competitive employment if included in the new state biennial budget. These monies will be distributed in June 2026 to districts with qualifying surveys.

District participation in the Indicator 14 Survey provides valuable data on district former students who exited school with a diploma, a certificate of attendance, by reaching the maximum age of eligibility for services, or by dropping out. Exiters are former students who have been out of school for one full calendar year and are eligible to participate in an Indicator 14 interview June 1 through September 30, 2025. To complete the district’s required activities, open the “**Survey Preparation and Timelines**” and “**Survey Assurances**” which can be found on the Welcome page of the www.indicator14wi.org website.

- This website is used to update exiter contact information, enter surveys, view district data and reports, and apply for the Special Education Transition Incentive Grant funds.
- Districts have the option to participate in the Transition Improvement Grant (TIG) interviewer training and conduct the districts’ Indicator 14 interviews or have St. Norbert College Strategic Research Institute (SRI) conduct the interviews on behalf of the district. SRI charges a \$40 set-up fee and then \$23.50 for each successfully completed survey. St. Norbert College SRI will bill the district after the close of the survey window and it is expected that the district will pay SRI promptly.

Please note two important Indicator 14 Activities to be completed:

- Assurance Page:** DSE/PS or other Leadership personnel must review, sign and send the Survey Assurance form to Jenny Jacobs. If district staff are conducting the interviews, include names and contact information of interviewers. Please submit the Assurance page no later than **May 28, 2025**.
- Survey Preparation Activities:** All preparation activities including entering contact information must be completed by **May 28th**. Contact Jenny Jacobs if you need to discuss an extension for these activities.
